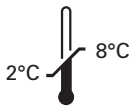

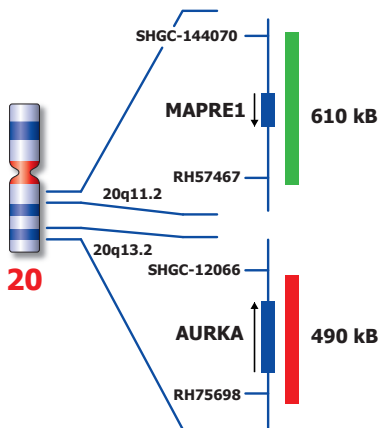

## Kreatech™ AURKA (20q13) / 20q11 FISH probe

**Introduction:** The **AURKA (20q13)** specific FISH probe is optimized to detect the AURKA gene region at region 20q13. The **20q11** specific FISH probe is included to facilitate chromosome identification.

**Critical region 1 (red):** The **AURKA (20q13)** gene region probe is direct-labeled with PlatinumBright™550.  
**Control region (green):** The **20q11** FISH probe is direct-labeled with PlatinumBright™495.

**Reagent:** Kreatech probes are direct-labeled DNA probes provided in a ready-to-use format. Apply 10 µl of probe to a sample area of approximately 22 x 22 mm.

**Please refer to the Instructions for Use for the entire Kreatech FISH protocol.**

**Kreatech FISH probes are REPEAT-FREE™ and therefore do not contain Cot-1 DNA. Hybridization efficiency is increased and background, due to unspecific binding, is highly reduced.**

**Patterns:** The **AURKA (20q13) / 20q11** FISH probe is designed as a dual-color assay to detect amplifications at 20q13. Amplifications involving the AURKA gene region at 20q13 will show several red signals, while the control at the chromosome 20q11 specific region will provide 2 signals. Two single color red (R) and green (G) signals will identify the normal chromosomes 20 (2R2G).
